*An Ordinance identifying surplus property that is no longer needed for public or municipal purposes*

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TUSKEGEE, ALABAMA, AS FOLLOWS:**

**WHEREAS**, the City of Tuskegee, Alabama has certain items of personal property which are no longer needed for public or municipal purposes; and

**WHEREAS**, Section 11-43-56 of the Code of Alabama of 1975 authorizes the municipal governing body to dispose of unneeded personal property; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Tuskegee, Alabama, as follows:

**SECTION 1.** It is hereby established and declared that the following described personal property of the City of Tuskegee, Alabama, is no longer needed for public or municipal purposes, to wit:

**WHEREAS**, as committed as Frank Cyrus was to his students, he was also committed to his family, friends and church, Washington Chapel AME Church. He was a dedicated member of Alpha Phi Alpha Fraternity, the Tuskegee Area Chamber of Commerce; a former member of the Tuskegee Industrial Development Board and the Tuskegee Citizens Advisory Board as well as the Star Mindingall Water Authority.
