FRANCHISE AGREEMENT

The **FRANCHISE PAYMENT AGREEMENT** between the City of Tuskegee, Alabama, a municipal corporation under the laws of the State of Alabama (herein called "the City") and the Utilities Board of the City of

Tuskegee, a public corporation organized under the laws of the State of Alabama (herein called "the Utilities Board"),

RECITALS:

The Board is a public corporation organized by the City under the provisions of Act No. 175 adopted at the 1951 Regular Session of the Legislature of Alabama (now codified as Article 9 of Chapter 50 of Title 11 of the Code of Alabama 1975) by proceedings taken by the governing body of the City and a Certificate of Incorporation filed in the Office of the Judge of Probate of Macon County, Alabama. Pursuant to the provisions of the said Act No. 175 and its Certificate of Incorporation, the Board owns and operates an electric distribution system (herein referred to as "the electric system"); a water works plant and distribution system (herein called "the Water Works System"); and a sanitary sewer system (herein called "the Sewer System").

NOW, THEREFORE THIS FRANCHISE AGREEMENT

WITNESSETH:

For the aforesaid purpose and in consideration of the respective agreements herein contained, it is hereby agreed between the parties signatory hereto, each with the other, as follows:

- **Section 1.** Contemporaneously with the delivery of this Agreement, the City has adopted an appropriate ordinance (herein called the "Franchise Ordinance") granting an exclusive franchise to the Utilities Board for the operation of the Systems in the corporate limits of the City for a period of thirty (30) years from the date hereof. The parties acknowledge that they must comply with the terms of the said Franchise Ordinance.
- **Section 2.** In consideration of the grant of the franchise provided for in the Franchise Ordinance, and subject to the provisions of Section 3 of this Agreement, the Utilities Board will pay to the City, not later than the fifteenth (15th) day of each calendar month (herein called the "Monthly Payment Date"), beginning with the month of November, 2016 and continuing in each calendar month thereafter for so long as this Agreement shall remain in effect, an amount equal to one-twelfth (1/12) of three percent (3%) of the revenues derived by the Utilities Board from the operation of the Systems within the corporate limits of the City of Tuskegee during the immediately preceding calendar year and received by the Utilities Board in cash (such payments being herein called "Franchise Fees"). All Franchise Fees payable by the Utilities Board to the City hereunder shall be paid to the City Treasurer at the Tuskegee Municipal Complex in immediately available funds.
- **Section 3.** Notwithstanding the foregoing, the obligations of the Utilities Board to pay Franchise Fees to the City hereunder shall be subject and subordinate to the obligation of the Utilities Board to make timely payment of all indebtedness or obligations of the Utilities Board incurred with respect to the Utilities Board's ownership, operation or improvement of the Systems (including, without limitation, the Utility Revenue Bonds, Series 2012 as well as any other indebtedness of the Utilities Board to any person or any financial institution) that may be outstanding at any time (collectively the "Outstanding Obligations"), except to the extent otherwise provided in the indenture(s) pursuant to which the Outstanding Obligations were issued. In the event that the Utilities Board shall not have sufficient moneys available to pay all or any portion of Franchise Fees that shall be due and payable on any Monthly Payment Date, then the unpaid amount of any Franchise Fees shall accrue and be payable cumulatively (but without interest) on the next Monthly Payment Date on which monies shall be available therefor.
- **Section 4.** This Agreement shall remain in effect for so long as the franchise granted by the Franchise Ordinance (or any renewal or extension thereof) shall remain in effect.
- **Section 5.** This Agreement shall in all respects be governed by and construed in accordance with the laws of the State of Alabama.
- **Section 6.** This Agreement shall be binding upon, and shall inure to the benefit of, the City, the Utilities Board and their respective successors and assigns; and shall also be construed to be a contract for the benefit of the holders of any indebtedness of the Utilities Board.

Section 7. <u>Severability</u>. In the event that any provision hereof shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision thereof.

IN WITNESS WHEREOF, the parties hereto have caused this Franchise Payment Agreement to be duly executed and delivered by their respective officers thereunto duly authorized as of this the 13th day of September, 2016.

ORDINANCE NO. 2016-8

AN ORDINANCE GRANTING AN EXCLUSIVE FRANCHISE FOR THE OPERATION OF ELECTRIC DISTRIBUTION, WATERWORKS AND SANITARY SEWER SYSTEMS AND APPURTENANT FACILITIES

BE IT ORDAINED BY the Mayor and City Council of the CITY OF TUSKEGEE (herein called the "City"), as follows:

- **Section 1.** The City hereby grants to the Utilities Board of the City of Tuskegee (herein called the "Board), its successors and assigns, the right, privilege, authority and franchise to acquire, construct, own, repair, maintain, enlarge, extend, improve, replace and operated an electric distribution system, a waterworks plant and distribution system, and a sanitary sewer system, as well as all appurtenant facilities (which are herein together called the "Systems") to serve the City and the surrounding territory and the inhabitants thereof and businesses and institutions situated therein, and to use the streets, avenues, alleys and public ways and places in the city for such purpose.
- **Section 2.** The City hereby grants to the Board the right, privilege, authority and franchise at any time and from time to time during the period covered by this franchise, in consideration of the payment by the Board to the City of the fees specified in Section 8 hereof, to construct, repair, maintain, enlarge, extend, improve and replace its wires, substations, mains, pipes, conduits and facilities in, over, under, across or along any street, avenue, alley or public way or place in the City and to make all excavations necessary therefore, for the purpose of constructing, repairing, maintaining, improving, enlarging, extending, replacing or operating any or all of the Systems.
- **Section 3.** The Board shall, and by accepting this franchise, agree that it will operate the Systems and keep the same in good repair and operating condition so as to provide adequate electric, water and sanitary sewer service to the City and its inhabitants, businesses and institutions at all times.

Section 4. The Board shall, and by accepting this franchise, agrees that it will, upon-making any excavation to the streets, avenues, alleys, public ways and places of the City in the exercise of this franchise, restore the surface and paving at the point of such excavation in the substantially the same condition as before the work was done, within reasonable time thereafter, and will save the City harmless from any liability arising out of any change in the condition of any street, avenue, alley, public way or place by the Board.

Section 5. The rights, privileges, authorities and franchise hereby granted shall continue in force and effect for a period of thirty (30) years from the effective date of this ordinance.

Section 6. The franchise herein granted shall be exclusive. The City hereby covenants and agrees not to grant any franchise for any electric distribution system, or any water system or sanitary sewer system to any person, firm or corporation other than the Board during the term of the franchise hereby granted, insofar as an exclusive franchise now is or may hereafter be authorized or permitted by law to a public corporation such as the Board.

Section 7. The City hereby consents and agrees that the franchise hereby granted may be covered by any mortgage, deed or indenture of trust executed by the Board for the purpose of securing the payment of the principal of and Interest on any bonds or other obligations (including any refunding bonds or refunding obligations) issued by the Board in order to acquire, construct, enlarge, extend, improve, replace, maintain, repair or operate the Systems, which the Board may hereafter acquire, and any such mortgage or deed or indenture of trust shall constitute, a lien on this franchise, and this franchise may be transferred or assigned in accordance with the provisions of any such mortgage or deed or indenture of trust; but this franchise shall not otherwise be transferred or assigned. The parties recognize that existing at the time of execution of the within Ordinance are the Utility Revenue Bonds, Series 2012 of the Utilities Board of the City of Tuskegee, issued by the Board in the principal amount of \$21,010,000, dated February 1, 2012 for a term of thirty (30) years, which, among other things, paid off the Series 1997 Bond of the Utilities Board of the City of Tuskegee.

Section 8. The franchise herein granted by the City to the Board is granted in consideration of the agreement on the part of the Board to pay to the City in monthly installments three percent (3%) of the gross revenues derived by the Board within the City limits from the operation of the Systems from the immediately preceding year. The said agreement of the Board shall be made pursuant to a Franchise Agreement (the "Franchise Agreement") that shall be in substantially the form presented to the Mayor and City Council of the City at which this ordinance is adopted (which form shall be attached to this ordinance as Exhibit 1 and which is hereby adopted in all respects as if set out in full herein), with such changes as the City Manager, acting with the advice of the City Attorney, shall determine to be necessary or desirable in order to consummate the transactions authorized by this ordinance; provided, however, that the determination of the definitive form of the Franchise Agreement by the City Manager shall be conclusively established by the execution of such document. The City Manager is hereby authorized and directed to execute and deliver the Franchise Agreement for and in the name and behalf of the City, and the City Clerk of the City is hereby authorized and directed to affix the official and corporate seal of the City to the Franchise Agreement and to attest the same.

Section 9. Severability. In the event that any provision hereof shall be held invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.

Section 10. Ordinance to become effective. This ordinance shall become effective, upon passage and publication as required by law.


