### Authorizing changes to personnel policy regarding annual leave & compensatory leave accrual

**WHEREAS,** The City Council of the City of Tuskegee, Alabama has determined that there is a need for a revision in the City of Tuskegee Personnel Policies as adopted on September 26, 2006 by Resolution 2006-88; and

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TUSKEGEE, ALABAMA AS FOLLOWS:

- 1. <u>Section III Leaves of Absence</u>, 3.03 shall be and the same is hereby amended, by adding a paragraph, numbered "7", so that Section 3.03 7 reads in its entirety, as follows:
  - 7. Employees with annual leave that exceeds 240 hours must establish a leave spend plan with their department head. The spend plan must provide a scheduled use of leave time in 8 hours increments, or shift coverage hours for public safety departments, that will exhaust all accrued leave above the permissible limits, within one fiscal year.

If an employee has earned leave that cannot be exhausted within a fiscal year, the employee shall develop a spend plan with their department head that exhausts the excessive leave within two fiscal years consistent with department coverage needs. Employees are responsible for arranging the use of the time earned and establishment of their spend plans with their respective department heads. Exceptions to this policy will only be provided under compelling extenuating circumstances. Employees neglecting to comply with this policy will lose two weeks or 80 hours per fiscal year.

- 2. <u>Section VI Administration of Pay and Overtime</u>, 6.03 shall be and the same is hereby amended, by adding a paragraph, numbered "3", so that section 6.03 3 reads in its entirety, as follows:
  - 3. Employees who have amassed compensatory leave time in excess of the established limit, must exhaust any additional compensatory time earned within two pay periods from when it has been earned.

**WHEREAS,** The City Council of the City of Tuskegee, Alabama has determined that there is a need for a revision in the City of Tuskegee Personnel Policies as adopted on September 26, 2006 by Resolution 2006-88, and

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TUSKEGEE, ALABAMA AS FOLLOWS:

<u>Section III – Leaves of Absence,</u> 3.11 Hazardous Weather shall be and the same is hereby amended, so that Section 3.11 reads, in its entirety, as follows:

"However, in the event an official determination is reached that travel is extremely hazardous and should be avoided, or if travel is denied due to the roads being closed by official action, the employee will be excused from appearing at the work place if his or her presence is not absolutely essential for required services such as, but not limited to, public safety, water purification and distribution, public works-road clearing, and any personnel needed as deemed appropriate to provide coverage consistent with the public need under the circumstances of the emergency.

When operations are officially closed due to an emergency, non-essential employees will receive their regular pay for the time off from scheduled work not to exceed three consecutive days. If an emergency exists resulting in an official closure of City operations beyond three days, non-essential staff must use any available leave time that they have accrued for each day beyond the third consecutive day of official closure, with the exception of sick leave. Non-essential staff lacking accrued leave will have their absences recorded as leave without pay.

When City operations are officially closed, essential staff must report to work as usual even though operations may be officially closed. In these circumstances, employees who work will receive regular pay in accordance with the provisions of applicable state and local regulations and an additional eight hours of pay at their regular rate, not to exceed three consecutive days. If an emergency exists resulting in the closure of City operations beyond three consecutive days, essential staff will receive regular payment for each day worked beyond the first three days of closure. Payment for overtime will be provided pursuant to applicable federal and state law for actual hours worked beyond the regular work week when applicable'.
