ORDINANCE NO. 2020-02 (Adopted)

**An Ordinance Establishing the Salaries of the Mayor and Council Members
for the City of Tuskegee, Alabama regarding the 2020 Municipal Election**

BE IT ORDAINED, BY THE CITY COUNCIL OF THE CITY OF TUSKEGEE, ALABAMA AS FOLLOWS:

- Section 1.** That the salary of the Mayor of the City of Tuskegee, Alabama shall be the same hereby fixed at \$28,000.00 annually to be paid in twenty-six (26) equal installments, bi-weekly.
- Section 2.** That the Councilmember-at-Large shall be compensated at the sum of \$11,700.00 annually to be paid in twenty-six (26) equal installments, bi-weekly.
- Section 3.** That each councilmember shall be compensated at the sum of \$11,000.00 annually to be paid in twenty-six (26) equal installments, bi-weekly.
- Section 4.** That the members of the City Council shall be entitled to participation in the insurance programs provided by the City of Tuskegee under the same terms as City employees.
- Section 5.** That this ordinance shall become effective on the first Monday in November, 2020 and shall continue in force and effect until repealed by action of the Council.
- Section 6.** The provisions of this ordinance are hereby declared severable; if any portion of this ordinance shall be held unconstitutional or otherwise invalid by a court of competent jurisdiction, such ruling shall not affect the remaining portions of this ordinance.
