**WHEREAS**, Alpha Kappa Alpha Sorority, Inc. is proud to join forces with the Alzheimer's Association to raise awareness of Alzheimer's disease risk factors, diagnosis, care, and advocacy, among the African-American community; and

**WHEREAS**, every 65 seconds someone in the United States develops the Alzheimer's disease and this disease is the 6<sup>th</sup> leading cause of death in the United States; and

**WHEREAS**, Alzheimer's is a disease that attacks the brain. It is the most common form of dementia. Dementia is a general term for a decline in mental ability severe enough to interfere with daily life. Stages show how the disease unfolds, but progression will vary greatly from person to person; and

**WHEREAS**, 16.1 million Americans provide unpaid care for people with Alzheimer's or other dementias; and these care givers provided an estimated 18.4 billion hours of care valued at over \$232 billion; and

**WHEREAS**, looking to the future a large segment of the American population – the baby boom generation – has begun to reach age 65 and older, ages when the risk for Alzheimer's and other dementias is elevated. By 2030 projected to be 615,000 and by 2050 – 959,000 will include new cases of Alzheimer's dementia; and

**WHEREAS**, by 2050, the number of people age 65 and older with Alzheimer's dementia may grow from 5.5 million to a projected 13.8 million, barring the development of medical breakthroughs to prevent, slow, or cure Alzheimer's.

**WHEREAS**, AKA has designated the Alzheimer's Association The Longest Day as a Community Impact Day and with the theme of "AKA-cise the mind and body." The members of AKA will raise awareness and make a difference in the fight against Alzheimer's disease; and
