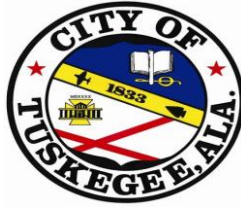


CITY OF TUSKEGEE, ALABAMA

ORDINANCE NO. 2020-03

**An Ordinance Amending Ordinance No. 2005-13 of the City of Tuskegee, Alabama,
Dated April 12, 2005 regarding Itinerant Vendors, Amending Section 7 - Fees**

BE IT ORDAINED by the City Council of the City of Tuskegee, Alabama, amends Section 7 (Fees) of Ordinance No. 2005-13, dated April 12, 2005 as follows:

Amended to read as:

Section 7. FEES (a) An applicant for license under this ordinance shall pay a license fee of \$25.00 per day, \$75.00 per week or \$200.00 a month per vendor; (b) Non-profit organizations shall pay a license fee of \$25.00 upon proof of non-profit status; (c) Festival Sponsors shall pay a fee of \$500.00 per event to defray the costs of police protection, fire protection, EMS/First Aid Services, and cleanup; (d) festival participants shall pay a fee of \$35.00 per event, except that non-profit organizations shall pay a fee of \$25.00 per event.

This Ordinance shall become effective upon its passage and publication as required by law.
