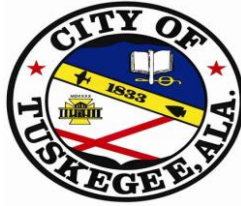


CITY OF TUSKEGEE, ALABAMA

The City Council of the City of Tuskegee met in a **Special Session on Tuesday, June 30, 2020** at 9:45 AM at the Municipal Complex, LM Gregg Auditorium, located at 101 Fonville Street, Tuskegee, Alabama. (*delay due to technical difficulties*)

- **July 2, 2020:** Last Day for council to adopt an ordinance establishing qualification fees. §11-46-2

 - Mayor gives notice of the election. §11-46-22(a)
 - Candidates may begin qualifying at city hall notice is published. Candidates must file a Statement of Economic Interest forms with the Alabama Ethics Commission to appear on the ballot.
