5. APPROVAL OF AGENDA.

Motion was made by Council Member Curry to approve the agenda as circulated. Council Member at Large Brown seconded the motion and all members voted aye. Mayor Haygood declared the motion carried.

6. **DISCUSSION ITEMS:**

A. Appointment of Temporary Acting City Manager.

Mr. Kelvin Owens was appointed to the position of City Manager by resolution number 2019-57 on August 21, 2019. He then subsequently declined to accept the appointment thereby leaving a vacancy in the office of city manager. Mr. Roberts was appointed due to a lapse of time in his of service is appointed as the Temporary Acting City Manager for a period not to exceed four months (120 days). Kelvin Owens will be in touch with the Mayor with reason why he declined position.

B. Rebuild Alabama Road Tax Funds.

Mayor Haygood presented information concerning Rebuild Alabama Road Tax Funds. This legislation was passed by the Legislature in Montgomery – the tax monies will be provided by the increased gas tax money collected by the state. The City of Tuskegee will have to carry over money from 2019 (\$40,000) which will be available next year in 2020. Approximately \$47,774.65 will be available in 2020. Half or more of the money must be used for materials to repair roads.

C. Red Tails Foundation.

The Red Tails Foundation met on the 28th of August at Moton Field in the new terminal building. Congressman Mike Rogers and his aide Alvin Lewis were at the meeting.

7. **RESOLUTIONS:**

A. Resolution No. 2019-59. Appointed to Serve as the Temporary Acting City Manager

Motion was made by Council Member at Large Brown to accept/approve resolution number 2019-59. Council Member Curry seconded the motion. Mayor Haygood declared the motion carried. The resolution was adopted.

BE IT RESOLVED by the City Council of the City of Tuskegee that Ulysees Roberts is hereby appointed to serve as the Temporary Acting City Manager for the City of Tuskegee for a period not to exceed four months from the date of this appointment under the terms of Section 11-43A-18 of the Code of Alabama. This action follows the adoption of Resolution 2019-57 on August 23, 2019 which appointed Kevin Owens as the City Manager but who subsequent to the appointment declined to accept the appointment thereby leaving a vacancy in the office of city manager.

This appointment is effective immediately upon adoption by the City Council of the City of Tuskegee.

RESOLUTION NO. 2019 – 60 Resolution to adopt Rebuild Alabama Transportation Plan

WHEREAS, During the 2019 Special Session, in an effort to address infrastructure funding, the Legislature passed House Bill 2 which increased the motor fuel tax by 6 cents in 2019, 2 additional cents in 2020, and 2 additional cents in 2021. HB2 also included the ATRIP-II program setting aside a state match program for local projects of public use; and

WHEREAS for 2019, \$30 million will be available for local governments to apply for. Expected funds and the accountability requirements imposed by the Act enforce requirements on the County and Municipalities as it relates to the expenditure of the funds created.

THEREFORE, RESOLVED that the City of Tuskegee, Alabama hereby adopt an annual Rebuild Alabama Transportation Plan in acceptance of ATRIP-II Rebuild Alabama Infrastructure Program.
