Position Description

General nature/purpose of work:

Performs solid waste and trash collection, grounds maintenance and street maintenance activities, follows safety procedures and performs related services: Rides on rear platform of packer truck along curbside pick-up and commercial routes; operates controls to empty into hopper and compact contents of containers and/or dumpsters; at end of daily operations, pressure washes truck; and on designated days lubricates truck. Mows grass using riding mower or walk-behind mower; prunes shrubs or hedges, using shears or pruners; trims and may trees fell and limb trees using chainsaw, bow saw or axe. Spreads and tamps asphalt using shovel and tamper to repair and patch pavement and fill potholes; may repair guardrails and street markers using hand tools and power tools; and may assist in forming, pouring and finishing concrete, screed, trowel and float. Assists in light maintenance of equipment and vehicles; picks up and disposes of dead animals; assists in clearing streets of fallen trees and limbs; may drive vehicle not requiring CDL; and may operate farm tractor with rotary cutter to mow fields or rights-of-way; moves furniture in buildings; and performs related tasks as requested.

- Meet appropriate physical requirements
